Requirements for participation in the selection procedure

- It is mandatory to hold a bachelor's degree in economics (L-18 - Economics and Business Management and L-33 - Economics). For students with a bachelor's degree in a different subject area, the Commission, in collaboration with selected partner universities, reserves the right to evaluate their academic background in order to decide whether or not to admit them to the Double Degree program.
- It is mandatory for all locations of the Double Degree programs of the Department of Economics and Management to show a level B2 of English or the level of language indicated in the list of the destinations. Please, refer to Language verification procedures indicated in the Call for applications (art. 7). If the host university requires a specific international language certification, it will be the candidate's responsibility to obtain it in due time (typically when the nomination process starts, and, in any case, by the time the candidate submits the application to the host institution and is required to attach the language certificate).
- It's mandatory to acquire 60 credits before departure, exceptions are indicated in each agreements published at: <https://internationalactivities.unipv.it/double-degree/partnership/>.
- Students who do not obtain their degree within 24 months from the validation of all the exams may be excluded from the Double Degree program and can therefore obtain their degree only at the University of Pavia. Exceptions to this rule will be evaluated individually and must be adequately documented and justified.

Disclaimer clause

Students selected for a double degree program cannot participate in other exchange programs. Any acceptance or assignment to other international mobility programs will automatically lapse.

Study Plan – Exam Recognition

Students admitted to the Double Degree programme must submit a Learning Agreement (LA) listing the courses they will take at Partner University. Only courses included in an approved LA and consistent with the inter-institutional agreements and the official study plans of both institutions may be considered for recognition.

Area-matching rule (mandatory): a course can be recognized only if it belongs to the same area as the corresponding component in the Italian study plan, as follows:

- Economics → Economics
- Management → Management
- Language → the same Language
- Internship → Internship

No match = no recognition: if a course taken abroad cannot be unambiguously matched to one of the areas above, it will not be recognized in the Italian study plan, and the relevant requirement must be completed in Italy.
